1. Introduction

According to the decision of the Scientific Council of Sumgayit State University dated 20.04.2022 (protocol No. 08), a Disciplinary Commission was established under the Scientific Council. The Disciplinary Commission plays a key role in maintaining a respectful, ethical, and professional academic environment. It ensures that all university members adhere to established codes of conduct and organizational values. Core Responsibilities:

- Investigating disciplinary violations in accordance with university regulations
- Reviewing complaints and claims submitted by students, faculty, and staff
- Promoting ethical behavior and adherence to organizational values
- Recommending appropriate measures or sanctions when necessary

This report is prepared based on the activities of the Disciplinary Commission during the 2024-2025 academic year and the results of the disciplinary cases considered. 5. Analysis and Key Issues

- The most common violation was unexcused absences.
- Violations of academic integrity mainly included providing illegal assistance in exams.
- Repeated violations were observed mainly among lower-year students.
- In most cases, students stated that they did not know the rules.

6. Awareness and Preventive Measures

- Educational events were held during seminar classes in 6 faculties on the topic of "Academic Ethics and Discipline".
- Internal rules were explained to newly admitted students.
- A simple explanatory version of the code of ethics was prepared for students.
- Policy documents prepared:
 - ✓ Ethical Organizational values;
 - ✓ Prevention policy on Human Trafficking;
 - ✓ Anti-Harassment;

- ✓ Anti-Discrimination;
- ✓ Equality, Diversity and Inclusion.

7. Recommendations

- Regular trainings should be held to introduce disciplinary rules in all faculties.
- Educational materials on academic integrity should be prepared.
